We welcome your participation in our symposium on **CHAOS & CRDER** held from October 14 to 19 as a part of this year's **Styrian Autumn**.

Your contribution to the symposium: Installation Keysnow and Artefact. The symposium will take place at: Grazer Messe. Halle 12. Duration of the symposium: October 14 - 19.

II.

Duties to be performed by the Company:

- 1. Honorarium: AS 10,000,-
- **2. Hotel expenses:** double room(bed & breakfast) from Oct. 10. to Oct.17. 1989. Hotel "Herberge". Extras must be paid by the quest.
- 3. Travel expenses: The Company reimburses US \$ 2.240.— For travel expenses upon arrival in Graz.
- 4. Per diems: Austrian Schilling 2000.— per day.

The honorarium and the per diems will be paid cash during the Contractee's stay in Graz (payment will be made in Austrian currency). The travel expenses will also be reimbursed in cash during the Contractee's stay in Graz against presentation of receipts (tickets etc.)unless there has been a different arrangement.

Special agreements:

You will place free of charge at the Company's diposal:

- 1. Short version of your talk for the translators.
- 2. Articles for press information (biography, photograph) and agree to the publication of articles to the press for which he holds the copyrights free of charge so that no costs will acque to the Company.

The following contractual terms are an integral part of this contract:

- 1. The parties hereto agree that, becomd the fee and additional services provided by the Company as stipulated in this agreement, no further payments and services will be made by the Company, and assure that payments conform the legal regulations.
- 1. All material, supplementary devices and services necessar, for the realization of the performance according to this agreement must be made or organized by the Contractee, unless other arrangments have been agreed upon (see lecthrical equipment). Latest data for special agreements September 15. 1989.
- 7. There is a possibility that the ORF (Austrian Radio and Television) as well as other TV and broadcasting companies will make recordings. The Contractee and/ or his partners basically agree to such recordings on their transmission. The radio/ TV company is entitled to transmit them in a revised, shortened or divided version. There is, however no obligation to transmission. It is agreed upon that from these productions or transmissions no financial claims can be made by the Contractee and /or his partners, since these claims are already included in the agreed fee.
- 4. In case of a publication about the symposium by the Company or any other publisher the Contractee and/or his partners agree to this publication. He agrees expressively not to make any claims out of this title against the Company or a third party. At the same time the Contractee entitles the Company to use and to publish these texts at any time for any purpose. The Contractee and/or his partners may make free use of these texts after the above mentioned publication.
- 5. The Contractee declares to have the copyrights for the texts used in the report or to have secured the copyrights. Any copyright claims out of this title will be debited to the Contractee's account.
- 6. The Company will be compensated and kept harmless from third parties claims by the Contractee and Yor his partners.
- 7. A legally effective obligation is realized by the redelivery of the duplicate of this agreement signed by the Contractee or his agent. The duplicate must be returned on September 15. 1797.
