Congratulations. We are happy to inform you that the following film or video work has been selected for inclusion in Round II of Brief Encounters, pending technical approval by WGBH-TV:

We had several hundred entries for this round of Brief Encounters, a co-presentation of CENTER SCREEN, Inc. and the WGBH Educational Foundation. Selections were made jointly by myself and Raquel Ortiz, WGBH Executive Producer for Community Affairs.

Rates of payment for unlimited local broadcast for a year as intermission spots on WGBH are on a sliding scale from \$100 to \$85 per minute as follows: 30 secs. to 4 mins., \$100 per minute; thru 5 minutes, \$95 per minute; thru 6 minutes, \$90 per minute; thru 7 minutes, \$85 per minute.

At this point, further communications, contact, payment, etc. will come from WGBH. For technical approval, the print or tape you sent will be shown to WGBH Technical Staff, and a better print or dub requested if necessary. If a work is rejected on technical grounds, even with a better print or dub, CENTER SCREEN will do its best to negotiate possible correction of the work for broadcast.

It should be noted that, following a labor dispute, WGBH has recently lost 16 engineers, and that the normal schedule for technical approval will be delayed, possibly until the end of the summer. If you need the print or tape back before then, or have any other questions, please contact me directly.


