In January, 1989, the American Museum of the Moving Image will present a four-month exhibition devoted to the work of video artists Woody and Steina Vasulka. The retrospective will consist of five installations, a photographic display of Woody Vasulka's electronically generated images and a single channel tape retrospective. A more detailed description of the exhibition is attached.

In the event you are unfamiliar with the American Museum of the Moving Image, it is the first museum in the United States devoted to the art, history and technology of motion pictures and television. The Museum will open to the public in its newly renovated permanent facility on September 10. I have enclosed some materials about the Museum with this letter.

The Vasulka retrospective will inaugurate the Museum's third floor gallery. As you can imagine, an exhibition of this nature requires a great deal of equipment and is extremely expensive to mount. It is, therefore, critical that we secure foundation and corporate underwriting through either the loan of equipment or a contribution. Such support would be prominently acknowledged within the exhibition itself and in all publicity and public relations materials.

I believe you are familiar with the Vasulkas and their enormous contributions to the field and to the video community. This will be their first major exhibition in New York City and I sincerely hope that you will join us to make it the finest ever, exactly the kind of event which the Vasulkas so clearly deserve.
