Dear Woody and Steina Vasulka,

We are planning to hold an exhibition of artists videp tapes from October 18th - 31st and, subject to our receiving the necessary grant aid, we should like to invite you to exhibit work in this show.

This is to be an exhibition of artist's video tapes from Great Britain, with additional contributions from America, Scandinavia and the Continent.

It is intended that this exhibition should follow up the impetus generated by the recent showings at the 'Third Eye Centre' in Glasgow and the Tate Gallery.

All work is to be shown on U-matic video cassette. I hope that you can send work on U-matic cassette as we will be unable to carry out transfers from other formats.

You are invited to send material of up to an hour's duration, for which payment will be £10 for tapes lasting 30 minutes or less and £20 for tapes lasting 30-60 minutes.

There will be formally programmed sessions lasting approximately 2 hours each evening as well as daily showings in which the audience will be able to request tapes. Each artist's work will have one programmed showing as well as being included in the 'library' for request purposes.

Arrangements for collection and delivery of work have yet to be made, but we will contact you on this matter as soon as possible.

I hope that these arrangements are satisfactory and look forward to hearing from you soon.

The exhibition will consist of daily showings, in which the audience will be able to request tapes from the 'library'. Provision will be made to enable several tapes to be viewed in separate areas of the Gallery.

Arrangements for delivery and collection of tapes will be made later, however as a guide we would need the tapes for the show to reach us at the latest by October 1st 177.

I wish to formally invite you to show work in the fourth 'Artists Video' exhibition, which will take place at Biddick Farm Arts Centre from October 29th to November 11th. As you may know, the exhibition consists of video tapes from Great Britain with additional contributions from many other countries. In previous years this exhibition has been very successful, drawing its audience from the entire United Kingdom.

You are invited to send material up to one hour's duration for which payment will be £39 for tapes up to 30 minutes and £51 for tapes lasting 31 - 60 minutes. I must point out that we are only interested in work which has not previously been shown in Washington.

All the work is to be shown on 'U-matic' video cassette. I hope that you will be able to send work on this format as we will not be able to make transfers.

During the exhibition period there will be a viewer request tape 'library', provision will be made to enable several works to be viewed in separate areas of the gallery. Listening stations, with headphones, will be provided in the smaller areas for 'intimate viewing'.

I should be grateful if you could let us know whether you can participate in this show as soon as possible. If you are unable to send work please return the enclosed 'NO' slip; if you can take part please let me know as soon as possible and return the completed catalogue information sheet to arrive no later than September 24th. Information arriving after this date cannot be guaranteed entry to the catalogue.

All tapes will, of course, be fully insured by the gallery whilst in our possession and in transit after the exhibition; the artists are asked to insure their work on the in-coming journey. As a guide, we would need to receive your tape by October 22nd at the latest.

I hope that you will be able to exhibit in this increasingly successful show and look forward to hearing from you very soon.

P.S. NOTES FOR YOUR DIARY

Catalogue information to arrive by September 24th, (earlier if possible).

Tapes to arrive by October 22nd (earlier if possible).

Exhibition on display October 29th - November 11th.

P.P.S. TAPES FROM ABROAD

We suggest that tapes mailed outside the British Isles should be sent by AIR MAIL and <u>not</u> by Air Freight, as previous experience proves AIR MAIL to be quicker and more reliable. Value Declarations for Customs should give an indication of the actual value of the tape material itself, not the value attributable to the information/art work contained on the tape.

Please mark your package clearly with the words "TEMPORARILY IMPORTED UNDER THE MAGNETIC TAPE REGULATIONS 1971" written in capital letters next to the Arts Centre's address. This helps to ensure a quick passage through Customs.

Tapes will be returned by First Class Post (U.K.), AIR MAIL (U.S.A., Europe) insured to the value stated on your information form, within seven days of the close of the exhibition.
