

#### ART AND TECHNOLOGY

This is an interdisciplinary course designed to acquaint students with contemporary art which depends on technology for its creation. Among the topics to be covered are: 1) the history and dramatic growth of technology-dependent art forms, 2) an examination of contemporary listening/viewing habits and expectations, and 3) an opportunity to meet a variety of contemporary artists working in this field.

The course will be divided into three parts; the first dealing with music, the second concerned with the visual arts, film and television, and the third, an opportunity to see and hear the creative projects undertaken by members of the class. The emphasis will be placed on experimentation and recent technical developments in these fields.

The focus of your work in the course will be an independent, creative project in one of the artistic areas which significantly involves technology. During the first two weeks there will be individual appointments to help you design the project. Depending on the nature of your creative project, you will be expected to present your work to the class during one of the final three meetings. A list of suggested projects is appended to the syllabus.

The assigned book for the course is <u>Digital Harmony</u> - On the Complementarity of Music and Visual Art by John Whitney, (Byte Books, 1980). Additional reading and listening assignments as listed will be available in the Paddock Music Library, Hopkins Center.

Grading will be based primarily on your project, participation in class discussion and on a weekly report. Reports will consist of your comments or questions on the lectures, readings, listening and/or viewing assignments for the previous week. Eight reports of at least 250 words will be due on the following dates: January 12, 19, 26, February 2, 9, 16, 23 and March 9. Absences will be excused only on receipt of a letter from the Dean of Students or Dick's House. All final projects are due on March 2, 1982 without exception.

#### SYLLABUS







La singularité des films expérimentaux se manifeste à tous les niveaux, de leur conception à leur diffusion. Celles-ci ne s'apparentent en aucun cas aux méthodes de cinéma de fiction ou documentaire, notamment du fait qu'elles tiennent compte de l'hétérogénéité et de la multiplicité du cinéma.

Les conditions de conception et de fabrication sont libres et spécifiques à chaque film. Le financement et les moyens de réalisation du film, fixés par le cinéaste, sont déterminants dans la réalisation.

La circulation des films, déjà évoquée au premier congrès des cinéastes indépendants à la Sarraz en 1929, trouva sa forme achevée en 1962, avec la création de la New-York Film-makers Cooperative par Jonas Mekas, principal instigateur du mouvement expérimental aux U. S. A. En 1974, en France a été créé sur le modèle américain la Paris Films Coopérative par Claudine Eizikman et Guy Fihmah (18 rue Montmartre 75001 Paris). La coopérative est non sélective et non commerciale; elle s'occupe strictement de la diffusion des films et bandes vidéo. Les cinéastes restent propriétaires de leurs droits d'auteur.

D'autres structures telles que Cinédoc, centre de documentation sur le cinéma expérimental accessible depuis 1979 aux chercheurs, programmateurs, journalistes... se propose de conserver et de faire circuler des documents déposés par les cinéastes (textes, photos de films, films en plaques "Frozen Frames") et tous les documents relatifs au cinéma expérimental et l'art vidéo.

Loin de vouloir être un panorama du cinéma expérimental et de l'art vidéo, le choix et l'agencement de chaque programme a été effectué en fonction d'axes de recherche liés aux composantes cinématographiques : couleurs, lignes horizontales, verticales, intermittence, balayage-vidéo, portraits, cadre, carnets filmés...

Les films présentés ne sont pas tous récents. L'un d'entre eux date de 1921 (Rythmes 21 de Hans Richter). D'autres au contraire sont très récents et n'ont jamais été montrés en Europe (Cantaloup et Artifacts de Steina et Woody Vasulka). La plupart des autres films ont été réalisés en France, lieu d'effervescence du cinéma expérimental depuis quelques années. Ils ont en outre participé à des manifestations nationales et internationales, mais l'évènement de cette semaine s'explique par la mise en contact du cinéma expérimental et du large public qui découvrira l'intérêt de ces travaux trop souvent mal connus.


