Dear Steina Vasulka:

We are writing to invite you to participate in the symposium "**Simplicity and Complexity in the Arts and in the Creative Process**" on December 4th and 5th, organized by SITE Santa Fe, international contemporary arts museum, and The Santa Fe Institute, a research and education center dedicated to new scientific research based on multidisciplinary collaborations.

Led by Nobel Laureate physicist Murray Gell-Mann and the poet Marcia Southwick, the conference will focus on the Institute's pioneering investigations into connections between the simple fundamental laws of nature and the complexity and diversity of human beings and the world around them. It will specifically address applications of the scientific notions of "Simplicity" and "Complexity" to the Arts and creative thinking, through dialogues amongst world-renowned artists, musicians, architects, art historians and scientists.

Other participants we are inviting are Laurie Anderson, performance artist; William Calvin, author; James Crutchfield, physicist; Frank Gehry, architect; Philip Glass, music composer; Michael Hawley, computer scientist; Jim Jarmusch, filmmaker and producer; Joseph Kosuth, conceptual artist; Steven Lavine, President, California Institute of Arts; Cormac McCarthy; Alan Rath, robotics artist; Lou Reed, musician; David Ross, Director of the San Francisco Museum of Modern Art; David St. John, poet; Moshe Safdie, architect; Chuck Stevens, neuroscientist; Kirk Varnedoe, Chief Curator, Dept. of Painting and Sculpture, Museum of Modern Art; Robert Venturi & Denise Scott Brown, architects; Bill Viola, video artist; Elyn Zimmerman, sculptor. *Alexis Smith Bob Demirew Robert Fitzpatrick*

The two-day program will consist of several closed sessions on Friday and Saturday, followed by a public event at which each participant will be asked to make a five-minute presentation of any kind connected to the private meetings. A panel discussion will follow these presentations.

Please find included an expanded statement prepared by Professor Gell-Mann on the topic of the symposium, as well as a recently published article by him on the concepts of simplicity and complexity. We are also enclosing a mission statement from each of the organizing institutions.

The symposium is planned in conjunction with the exhibition **ALAN RATH: ROBOTICS**, which includes new interactive electromechanical sculptures by this internationally acclaimed artist.

- Professor Gell-Mann's statement:

“We envisage a two-day seminar involving artists and scholars of art history together with theoretical scientists who study concepts of simplicity and complexity.

One meaning for the complexity of an entity is the length of a very concise description of its regularities, as opposed to those features treated as random or incidental. The regularities that are identified depend to a considerable extent on the observer's experience and also on the level of detail (coarse graining) at which the entity is described. In connection with a work of art, they might refer to visual or auditory patterns, to characters and subplots in the case of a novel, and so forth. An entity may be said to be simple when its regularities that are under consideration can be briefly categorized. In a case of a work of art, of course, associations on the part of the observer would be normally included, making for greater complexity.”


Between **SITE Santa Fe, The Santa Fe Institute and Steina Vasulka**
